Prospective Purchasers will not be notified separately of the arrangement.

1. 先到先得。任何有意購買指明住宅物業的人士（下稱「準買方」）（如準買方是公司，則其任何一位董事）須遵從下列程序：

| <p>Other Matters:<br/>其他事項：</p> | <p><b><u>On 21 March 2017 to 23 March 2017 (10:00 a.m. to 7:00 p.m. everyday) and 24 March 2017 (10:00 a.m. to 2:00 p.m.)</u></b>, Prospective Purchasers are offered and invited to view the Specified Residential Property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the Specified Residential Property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as “<b>Properties for Viewing</b>”). In order to maintain order at PARK CIRCLE Venue and ensure the smoothness of the selection and purchase procedures, after a Prospective Purchaser has selected a specified residential property, the Prospective Purchaser will be required to proceed with the signing of Preliminary Agreement for Sale and Purchase of that Specified Residential Property, and that Specified Residential Property will not be held for the Prospective Purchaser’s viewing of any of the Properties for Viewing prior to the signing of the Preliminary Agreement for Sale and Purchase.
