#### (II) Procedures for Session A

1. Eligible persons interested in purchasing any of the Specified Residential Properties that will be offered to be sold in Session A ("Form A Special Units Registrant") must follow the rules set out in the Abstract in Section (I) and the procedures specified in Sections (II) and (IV) of this Sales Arrangements.

- 2.
