to the PARK CIRCLE Venue within the check-in timeslot on the first date of sale. - 4. After verification of the identity of the Registrants, the order of priority for selection of the specified residential properties will be determined by balloting which will take place at the PARK CIRCLE Venue after the check-in timeslot. - 14. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting).
