# On 11 November 2017 ("the first date of sale"):

- 1. Balloting will be used to determine the order of priority. Eligible persons interested in purchasing any of the specified residential properties ("**Registrants**") must follow the rules set out in this Sales Arrangements.
- 2. For the avoidance of doubt, all valid Registrations of Intent (if any) previously submitted to the Vendor prior to the first date of sale are hereby declared invalid and will not be included in the balloting.
- 3. Registration Slips will be distributed at the PARK CIRCLE Venue on the first date of the sale (from 10:00 a.m. to 10:15 a.m.) ("check-in timeslot"). to the PARK CIRCLE Venue within the check-in timeslot on the first date of sale. Registrant who arrives at the PARK CIRCLE Venue beyond the check-in timeslot shall not be eligible to participate in the balloting. The closing time for submission of Registration Slip will be 10:15 a.m. on the first date of sale.

- 4. After verification of the identity of the Registrants, the order of priority for selection of the specified residential properties will be determined by balloting which will take place at the PARK CIRCLE Venue after the check-in timeslot. Every valid Registration Slip shall be allotted one lot. Subject to the completion of the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting).
- 15. The Vendor reserves the right to close the PARK CIRCLE Venue at any time if all the specified residential properties have been sold out, provided that the PARK CIRCLE Venue shall be open for the collection of unused cashier order(s) at the time period specified in paragraph 10 above.
