On 14 January 2020 to 16 January 2020 (10:00 a.m. to 7:00 p.m.), Prospective Purchasers are offered and invited to view the specified residential property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the specified residential property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as "**Properties for Viewing**").
