According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance,-

第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3) 條 / Section 53(3)

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase – (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Special Discount

- (a) 凡於2016年8月31日或之前簽署臨時買賣合約，買方可獲4%售價折扣優惠。

Where the preliminary agreement for sale and purchase is signed on or before 31 August 2016, the Purchaser will be offered 4% discount on the price.

the Purchaser has settled the balance of the purchase price of the designated residential property in accordance with the agreement for sale and purchase.

After the Vendor has received the application and duly verified the information, the Vendor will apply the YOHO Life Cash Rebate for part payment of the balance of the purchase price of the designated residential property directly.

The final interest rate will be subject to approval by the designated financing company.
