- 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the PARK CIRCLE Venue before the commencement time of sale.

On 21 March 2017 to 23 March 2017 (10:00 a.m. to 7:00 p.m. everyday) and 24 March 2017 (10:00 a.m. to 2:00 p.m.), Prospective Purchasers are offered and invited to view the Specified Residential Property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the Specified Residential Property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as "Properties for Viewing").
