Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the <a href="Prospective Purchaser">Prospective Purchaser</a>. Each cashier order shall be in the sum of HK\$200,000 and made payable to "MAYER BROWN JSM".
- 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the PARK CIRCLE Venue before the commencement time of sale.
- 3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).

On 11-13 January 2017 (10:00 a.m. to 7:00 p.m.) and 14 January 2017 (10:00 a.m. to 3:00 p.m.), Prospective Purchasers are offered and invited to view the Specified Residential Property(ies) which he/she/it intends to purchase or their comparable residential properties if it is not reasonably practicable for the Specified Residential Property(ies) to be viewed by the Prospective Purchasers (the residential properties that are made available for viewing are collectively referred to as "Properties for Viewing").
